# COMMUNICATIONS AND PETITIONS

#### Update on Connecticut Harm Reduction Alliance Partnership by Department of Health and Social Services

Laurence Burnsed, Director of Health and Social Services, shared that CTHRA provides a multitude of services for residents, including substance use treatment options and referrals, health screenings, shelter referrals, syringe exchange, free works kits to reduce the risk of infectious disease infection from injection drug use, condoms, and free Narcan. Their mobile vehicles are also often stocked with sandwiches and other foods, as well as hats and gloves (depending on donations received) for residents in need. The Department of Health & Social Services is in the process of distributing information about the mobile services. Funding for mobile harm reduction services is currently supported by the fiscal year 2023 State of Connecticut Department of Public Health Per Capita grant through June 30, 2023. Monthly reports will be provided to Health & Social Services regarding number of clients served and types of services delivered.

# **OPPORTUNITY FOR COUNCILLORS TO DIRECT QUESTIONS TO THE ADMINISTRATION**

<u>Councillor Tsegai</u> requested an update on the Wickham Library project. The Mayor shared that Wickham Library is nearing completion – the Project Architect issued a Notice of Substantial Completion on December 19. The EH Building and Inspections Department has identified minor modifications that are needed before a Certificate of Occupancy can be issued. The Project Team is presently addressing those items and expects the CO to be issued this month.

The Councillor also made note of a lack of exterior lighting and available water fountains at the Goodwin School gym.

<u>Councillor Bell</u> thanked the Administration for their involvement with the Lions Club in providing residents with holiday baskets of cheer. The Councillor requested an update regarding Hockanum Trail repair. *The Mayor stated that while funding was announced in late Spring 2022, Federal rules require an environmental approval prior to funds being spent. That approval was finally received in early December. Downes Construction will handle the project management and an expedited RFP will be issued.* 

Councillor Bell then voiced concern over the current process for residents looking to engage with the Tax Office during the relocation of the department to the CCC building, particularly for cash collection. The Mayor stated that at Town Hall, the office was protected with bullet-proof glass and other measures to assure the safety of residents and staff. Administration is encouraging residents to mail checks and use online resources and is reviewing other processes to provide accommodations to residents.

<u>Councillor Rup</u> requested an update on the Silver Lane Plaza project. The Mayor stated that title to the properties should be transferred to the Town around January 18<sup>th</sup>.

<u>Councillor Simpson</u> requested that the Tax Office make more of an effort to provide personal service to residents with unique needs now that the town hall office is no longer accessible. *Chief of Staff Martin stated that additional accommodations have been made in the last few days by staff as they've settled in to their new office location to work with residents directly as needed.*
