#### COMMUNICATIONS AND PETITIONS

#### Liaison Report: Metropolitan District Commission

<u>Chair Kehoe</u> explained that the Town Council liaisons for the East Hartford Housing Authority (EHHA), Riverfront Recapture and the Metropolitan District Commission (MDC) were asked to update the Council every six months on what the agency that they are assigned to is currently working on. EHHA gave their report at the April 20<sup>th</sup> meeting and Riverfront Recapture at the May 4<sup>th</sup> meeting.

Tonight's report is from the Metropolitan District Commission (MDC) presented by <u>Awet Tsegai</u>, the Town Council liaison for this agency. Councillor Tsegai introduced the following individuals from MDC: <u>Nick Salemi</u>, Communications Administrator and <u>Susan Negrelli</u>, Director of Engineering. They provided the Council with a PowerPoint presentation on the infrastructure that MDC has in East Hartford, including the eleven sewer pump stations located in town. Recently completed water projects include over 3 miles of new water mains replaced in various locations in town; recently completed sewer projects include 5 miles of lining of sanitary sewer mains in various locations in town. Currently, MDC is working on their Vegetation Management Program and updating the East Hartford Water Pollution Control Facility.

#### Disposition of Town-owned Property Other Than Real Estate re: Section 10-3 (c)

<u>Chair Kehoe</u> stated that there are various pieces of obsolete and old furniture and equipment in the Health and Police Departments that would not serve any purpose to keep. Pursuant to §10-3 (c) of the Code of Ordinances, the Mayor must notify the Council of her decision to dispose of such furniture/equipment. No action by the Council is necessary.

#### Resignations of Craig Stevenson and Marie Beaulieu

<u>Chair Kehoe</u> announced the resignation of (1) <u>Craig Stevenson</u> from the Economic Development Commission; and (2) <u>Marie Beaulieu</u> from the Commission on Services for Persons with Disabilities and Liaison to the Commission on Aging. The Chair thanked both individuals for their dedication to the town.

## Economic Development Tools: City & Town Development Act and State & Local Bonding Authority

Attorney <u>David Panico</u>, Partner, Robinson & Cole, is the town of East Hartford's Bond Counsel. He led a PowerPoint review of the Connecticut City and Town Development

Act, which the Town Council originally approved in August 2016 and the voters adopted through referendum in November 2016. The CCTDA remains in force for 5 years from the date it is adopted. Attorney Panico summarized the powers of the CCTDA which are very beneficial to a developer, especially tax abatement agreements and PILOT (payment in lieu of taxes) agreements.

Mayor Leclerc and Eileen Buckheit, Development Director reviewed with the Town Council the various 'tools' that can be used by developers in East Hartford to spur development in town. Mayor Leclerc went over the existing funding for development, showing the various sources of the funding, the amount expended and the remaining balance. They also reviewed the various tax abatement authorities that are available for the town to use.

<u>Collective Bargaining Agreement: East Hartford Board of Education and the East Hartford Federation of Paraeducators</u>

<u>Chair Kehoe</u> stated that the Council received the new union contract between the East Hartford Board of Education and the East Hartford Federation of Paraeducators (Paraprofessionals). This agenda item is informational only. No Council action is required.

47th Year Community Development Block Grant Action Plan

WHEREAS citizen input was obtained, in accordance with the Grants Administration Office's Citizen Participation Plan, at one Public Hearing held on November 30, 2020 and two Public Hearings held on March 22, 2021.

**NOW, THEREFORE, BE IT RESOLVED** that the Town Council of the Town of East Hartford recognizes the need for funding the objectives contained in the Forty-seventh Program Year Action Plan and endorses this Plan as reflecting the Town's Community Development needs.

AND, FURTHER, BE IT RESOLVED that the Town Council does support and authorize the submission of the 47th Program Year Action Plan, and Grantee Certifications to the U.S. Department of Housing and Urban Development and authorizes its Mayor, Marcia A. Leclerc, to act as representative of the Town and to enter into contract and any amendments thereof with the U.S. Department of Housing and Urban Development.

#### Recommendation from Tax Policy Committee: RFP - Tax Lien Sales

to authorize the administration to conduct a tax lien sale by way of a request for proposal (RFP) and to seek and receive sealed bids pursuant to an invitation to bid on a number of tax liens held by the town on specific real property, totaling \$1,869,401.97, as stated on lists produced by Finance Director Linda Trzetziak and attached to a memorandum dated April 14, 2021 from Mayor Marcia Leclerc to Town Council Chair Richard Kehoe, subject to the following four conditions:

- 1. The Collector of Revenue shall notify the record owner of each property subject to a lien that is to be included in the tax lien sale, by certified mail, that the lien is being included in the request for proposal and invitation to bid, and that the owner should contact the Town immediately to pay the taxes or seek a payment plan if they wish to keep the Town's tax liens on their property from being sold;
- 2. In order to qualify for a payment plan, the property owner must meet the following three criteria:
  - They must remit 25% of the outstanding amount due
  - They cannot have defaulted on a prior payment arrangement
  - Their property must not have active property code violations;
- 3. The letters from the Collector of Revenue to each property owner shall notify the property owner that the purchaser of the tax lien on their property shall have the right to foreclose on that property; and

4. The Administration shall return to the Town Council with the results of the request for proposal and that the proposal for each tax lien must be approved by the Town Council before it is sold.
