CALL TO ORDER

Chair Kehoe called the meeting to order at 7:38 p.m. The Chair announced the exit locations in accordance with Connecticut General Statutes §29-381, after which the Council joined him in the pledge of allegiance.

The Chair called for a moment of silence to honor the life of Salvatore "Jerry" Ingallinera, a longtime resident of East Hartford, who served as a Chair of the East Hartford Board of Education during the time when schools were being closed – a difficult time in the district's history. Mr. Ingallinera remained active in town politics after his service to the Board of Education, including involvement in several community and religious organizations. He will be missed.

OPPORTUNITY FOR RESIDENTS TO ADDRESS THE COUNCIL ON AGENDA ITEMS

Susan Kniep, 50 Olde Roberts Street, (1) suggested that the Town Council schedule a meeting with the Board of Education to discuss how to improve students' test scores; (2) asked that the Town Council hold meetings with the Board of Education quarterly; and (3) applauded Mayor Leclerc for her efforts in transparency by posting employee salaries and benefits to the town's website.

Mayor Leclerc commented on (1) the ribbon cutting at United Technologies Research Center was held on Friday June 2nd; (2) the Hartford-East Hartford Coalition's application for the creation of an Innovation Zone was awarded a \$2M grant; (3) the road improvement program has begun; (4) the Department of Public Works Week was a success; and (5) a new Dispatch Supervisor – a veteran retired police officer from Vernon– has been hired by the EHPD.

Hockanum School Flooring Abatement Project

RESOLUTION TO ADD A PROJECT TO THE TOWN'S 5-YEAR CAPITAL IMPROVEMENT PLAN, TO AUTHORIZE AN APPROPRIATION, TO AUTHORIZE THE FILING OF A GRANT APPLICATION, TO SEND THE PROJECT TO THE PUBLIC BUILDING COMMITTEE, AND TO FUND THE LOCAL SHARE OF THE PROJECT COST

WHEREAS, the Town of East Hartford Board of Education has identified that a flooring abatement project at the Hockanum School is a priority of the school district and qualified for State School Construction reimbursement; and

WHEREAS, the cost of the abatement including design and construction is anticipated to total \$330,000 with the State reimbursing 76.43% or \$252,219 leaving the School District to pay 23.57% or \$77,781.

THEREFORE BE IT RESOLVED, that the East Hartford Town Council does hereby approve the following items:

- 1. The addition by resolution to the Town's 5-Year Capital Improvement Plan, the Hockanum School Flooring Abatement Project in the amount of \$330,000,
- 2. The appropriation of \$330,000 to fund the Hockanum School Flooring Abatement Project into the Board of Education's Capital Reserve Account,
- 3. The authorization of the East Hartford Board of Education to apply to the Commissioner of Education and to accept or reject a grant for the Hockanum School Flooring Abatement Project,
- 4. That the Town's Public Building Commission is hereby charged with the oversight and approval of the Hockanum School Flooring Abatement Project,
- 5. That, in accordance with Article 7 §10-38 of the Town of East Hartford Code of Ordinances, the approval of the Board of Education's request to expend \$80,000 from the Board of Education's

Capital Reserve Account for the purposes of funding the local share of the Hockanum School Flooring Abatement Project,

6. That the Town of East Hartford hereby authorizes at least the preparation of schematic drawings and outline specifications for the Hockanum School Flooring Abatement Project.
