111 Ellington Road

13-17 Village Street

This is a town-owned property which formerly (1979) had been leased to the abutting business (Hartford Restoration Services) for its use as a parking area. The lease expired in 1999, and the property has continued to be used as parking for the business. Under consideration by the Committee was the formalization of the arrangement through the granting of an Easement Agreement.

that this Committee, cognizant of all pertinent and applicable surveys and in receipt of the Planning and Zoning Commissions' favorable 8-24 report, and having determined to negotiate directly rather than seek bids, recommends that the Town Council, subject to Army Corps of Engineers approval, grant an easement to 13-17 Village Street LLC, in the form attached hereto, for the purposes of parking vehicles on Town land abutting the Town's levee, as such land is described in the attached easement, and in recognition of the fact that such property has been used for over 40 years for this purpose, waive the appraisal requirements set forth in 10-19 (c) of the Town Ordinances.

The consensus of those present was that the Town had no need to acquire the property.
